Work to begin on Monday 27 February, resident webinar Wednesday 1 March

I'm pleased to say that the project to remediate the external wall system at Vantage Point will begin on **Monday 27 February.** We will be holding a resident webinar on **Wednesday 1 March at 6pm** to go over the details of the project and you'll be able to ask us any questions you have.

What work will be happening in the first couple of weeks?

We'll be getting started on-site a couple of days before we hold the webinar as we'll be getting the site set up and ready for the scaffolding to be built. Over the first few weeks, we'll be:

- Setting up the site offices and welfare facilities
- Closing off some street parking spaces (more info below)
- Receiving delivery of scaffolding and materials
- Beginning to build scaffolding from Monday 20 March.

Balcony usage

During the project, you won't be able to use your balconies. If you have any items on your balcony, you will need to remove them during the project. We may be able to offer some help if you have larger items which don't fit in your property – please get in contact with our resident liaison officer Zoe Kyriacou on **0204 512 5947**.

Parking restrictions

We will need to close street bays on Berger Road and Digby Road for the duration of the project. If you have a car, please be aware that these bays will not be available to park your car.

- Introduction to the building safety team and contractor
- The remediation we'll be doing at your building
- The project dates, site plan and layout
- Parking restrictions
- Clearing balconies and balcony use
