Remedial work expected to start Spring/Summer 2024

We're still making good progress on the preparation work for the required external wall system remediation at Grand Union Heights.

At the moment, we expect to be able to start the remediation work in Spring/Summer 2024. Once we've got confirmation of the start date, we hold a webinar to share all the necessary information with you.

'Leaseholder letter'

Some of you may be waiting for an EWS1 form (EWS – external wall system) which certifies the fire risk of a building. It can also be a requirement for lenders to lend on a building. Close to the project start date we will be able to share a leaseholder letter with you – this outlines the start/finish date, funding and remediation and has helped people to sell their homes at other projects. So you may not need to wait until the end of the project for an EWS1 form to be able to sell.
