## EWS1 form now available

I am really pleased to be able to confirm that our fire engineer has now issued an EWS1 form (EWS – external wall system) for your buildings. Following the remedial work to the external wall system, this certificate confirms that your building has been rated as 'B1 – the fire risk is low, and no remedial work is required'.

We carried out our own due diligence on the information we have received from the fire engineer and are happy with the rating received and justification given. We've included a cover letter for the document, signed by our fire engineer, which can sometimes be a requirement for lenders.

For those of you who have been looking to sell or remortgage, we hope that this will help you to do so. And for all of you, we hope this provides you with the peace of mind that the work has been completed effectively.
